Chief Moore - passed out information booklet. They are requesting a \$75 parcel fee to build two new fire stations, equip and maintain them. The Fire Protection District's current fire stations are up to 50 years old. According to the National Fire Protection Standard set by the Federal Government, they are required to be on a scene within 5 minutes and 20 seconds. There are some areas in FPD #4 which cannot be reached earlier than 9 to 10 minutes. It is his job to make sure they meet the response times and protect the citizens of the district. Also, the Fire Rating Bureau has repeatedly stated that the District needs new fire stations.

Mitchel Christen - the response problems the Chief referenced are being caused because of the fact that the Parish has allowed too much over development. There is no more quality of life because of it. St. Tammany Parish is paying higher millages than most of the New Orleans area.

O'Brien - the law requires the Chief to get the Council's permission to put this to a vote. She respectfully asks her colleagues to allow the people the rights to make the decision about the parcel fee and millages. If the people do not want it, they will vote no.

Groby - he like the fact that the District's audit had no items to address and had resolved the issues from last year's audit. He supports the effort to let the citizens vote.

Toledano - why this timing?

Chief - he started in 2014, and it took a while to get all of the information he needed to do this. Out of respect for the Parish, they delayed until now.

Toledano - the fair thing is to allow the will of the people to control the vote.

Lorino - he attended and would like for the Citizen's Academy to be open to the public at least once a year, so people will see the way the firemen work. He thinks the residents of Fire Protection District No. 4 should be allowed to decide.

Council Discussion ensued.

Chuck Camarche - President of Cross Gate Homeowner's Association - they have problems with sewerage backing up into the houses in this area. (Passed out information) The clean outs stand two feet high. It would be impossible that for the clean-outs to work the way it was described in Tim Brown's letter.

Neil Waguespack - He lives in Turtle Creek. The problems of raw sewerage coming out of manholes and the treatment Station extend to many subdivisions. They are refusing to pay dues because they live with sewerage health and safety issues. They blame Ms. Brister.

Bellisario - they have been dealing with this since 2007. He has met with Greg Gordon and Gina Campo and they made some changes, but they are still working on other issues, including relocating a lift station. He proposes that a work group be formed in order to review and understand these reports.

Raymond Frey - this is about Lots 60 and 61. He went to the Zoning Board because this a vacant lot next to an apartment complex which is not in good condition. A single family residence next to the complex would not have any value. Any new construction would be an uplift. He wants to help improve the area, not bring it down.

Elizabeth Peak - she was a realtor and for several years before she started buying, selling and leasing properties on her own. There are a lot of properties in this area that are in need of improvement. The prices lower as lots are in disrepair. They want to build a duplex, which they feel will improve the area and bring further development to the area.

Frey - the zoning is very mixed and includes many multi-units.

Paul Brooks - property values are going up. The problem with one of the houses in disrepair is because the couple owners died. They do not want to live in an area with duplexes. They feel duplexes will bring down the property values. There is a lot of traffic because of the school. The six units have been sold and will probably will be renovated. He built his house there because it was single family. The man who made a bad deal should have researched it before he bought.

Blanchard - she drives through this area everyday, and there are a lot of cars on the road. She appreciates that Mr. Frey wants to make a positive impact. However, there are some rather nice houses which were built recently. She can't support duplexes because she hopes that more single family houses will come in.

Bellisario - moved to concur with the Zoning Denial, second by Canulette. Unanimous with no one absent.

(Thompson)

Thompson - moved to adopt, second by Tanner. Unanimous with 1 absent (Groby); becomes Resolution C.S. No. C-5000.

Blanchard - 3. Resolution to vacate, in part, the six (6) month moratorium established by Ordinance C.S. 15-3392 and any subsequent extensions thereof, on the receipt of submissions by the Parish Zoning and Planning Commissions for the rezoning or re-subdivision of property and/or on the issuance of permits for construction or placement of any building structures on property south of Interstate 12, north of Highway 190, west of Highway 11, and east of the Precinct S19 Boundary Line within unincorporated boundaries of Ward 9, District 14. (Smith)

Smith - moved to adopt, second by Bellisario. Unanimous with 1 absent (Groby); becomes Resolution C.S. No. C-5002.

Blanchard - 4. Resolution to vacate, in part, the six (6) month moratorium established by Ordinance C.S. No. 15-3353 and any subsequent extensions thereof, for the limited purpose of allowing the issuance of permits for construction or placement of building structures within a portion of Voting Precinct 914. (Ward 9, District 14) (Smith)

Smith - moved to adopt, second by Binder. Unanimous with 1 absent (Groby); becomes Resolution C.S. No. C-5003.

There being no further business, meeting adjourned at the call of the Chairman.
