Non-Substantial Amendment Number 5 to St. Tammany Parish Government's Action Plan for Disaster Recovery – Utilizing Funding from the Disaster Relief Appropriations Act, 2013 (Public Law 113-2).

1. Introduction

This Action Plan Amendment describes a change in the utilization of funding allocated to the Tchefuncte Corridor Revitalization Project and Program Administration. This Amendment moves funding from the Tchefuncte Corridor project to Program Administration per the updates to the *Proposed Use of Funds & Activity Information* section that are noted below. The remainder of the Action Plan is unchanged.

2. Amended Language

As demonstrated in the Needs Assessment, St. Tammany has dedicated significant resources and has received significant funding to address the current needs of affordable housing, hazard mitigation, and infrastructure. The prominent need that remains unmet is sheltering and economic revitalization. The majority of the funding allocation will directly benefit the indicated programs. The Parish has, however, budgeted 2.5% of the allocation for program administration, which includes master planning both of the economic revitalization and infrastructure focus areas.

As demonstrated in the Needs Assessment, St. Tammany has dedicated significant resources and has received significant funding to address the current needs of affordable housing, hazard mitigation, and infrastructure. The prominent need that remains unmet is sheltering and economic revitalization. The majority of the funding allocation will directly benefit the indicated programs. The Parish has, however, budgeted 5% of the allocation for program administration, which includes master planning both of the economic revitalization and infrastructure focus areas.
