Stefancik - moved to adopt the consent calendar less items pulled, second by Groby. Unanimous with 1 absent (Bellisario).

Tanner - 1. Resolution C.S. No. C-4247 - Resolution to vacate, in part, the six (6) month moratorium established by Ordinance C.S. No. 13-2939, and any subsequent extensions thereof, for the limited purpose of allowing the approval of permits for construction or placement of building structures on 2.32 acres on Highway 1088, Section 6, Township 8 South, Range 12 East, being 22531 Highway 1088, Mandeville. (Ward 4, District 5) (Stefancik)

Hernandez - he has spoken to Mr. Stefancik who sponsored this Resolution. He is concerned that this is the first time this moratorium will be vacated. He has no problem with the church, but he would like for them to down zone from HC-3. Churches begin in NC zones, which has sizes which will accommodate the church planned.

Groby - when he and Mr. Gould decided to protect the area under a moratorium, the language prevented the fact that the church wants to tear down an existing building and build a new one.

Stefancik - this is a relatively small congregation with services on Sundays and the Wednesdays during Lent.

Smith - he wonders how the property could be down zoned without affecting the building the church want to do in order to put in a more appropriate zoning for a church.

Tanner - he does not feel that the Council should request that from the church.

Gould - thinks Mr. Hernandez should approach the church with his request. The Council is only vacating the moratorium, not hearing a rezoning case.

#### **APPEALS**

Tanner - 1. Samuel Markovich, on behalf of Acadian Properties Northshore, LLC, appealing the Zoning Commission DENIAL on October 7, 2014 for a waiver of the required 50 foot buffer and parking setback and of the landscaping requirements to accommodate for road improvements along LA Highway 21. (Ward 1, District 1) (CP07-09-157PR)

Sam Markovich - lives in Metairie. He thinks this is a simple case of the state came in and took part of his property to widen the road, and he would like some waivers of the buffers because of it. His property has been damaged.

Slifer - there has been a planned corridor overlay on Highway 21 for 25 years, so any developer who is doing projects in the area, should be well aware of the fact that some of the property would be taken for the widening of the road. Mr. Markovich will not even meet with the AOA to negotiate a compromise, not to mention there are other violations on the property which need to be addressed.

Dwain Meche - he encourages the Council to uphold the denial and enforce the Highway 21 guidelines. There are concerns about dirt which was brought onto this property and is causing drainage issues.

Markovich - the drainage issue was resolved by the engineers who said that when the site is developed there will not be drainage issues. He already has a building permit and the site plan was approved.

Slifer - there is no current project for this site, and if there is, no one has been given the chance to review anything.

Meche - he has some photos from residents showing what the drainage issues are.

O'Brien - the gentleman stated that there was a design for this project?

Sidney Fontenot - the project has approval as a PUD. Shortly before the PUD would expire, the land was cleared to prevent the expiration. There is not an active permit at this time. His current plan cannot be built because the widening of the road will take away the buffer which was included in the plan from 2007.

Dean - the conditional use permit was for 2 years and has since expired.

Fontenot - the permit does not expire if the property is occupied, which is what happened when the property was cleared. They only way Mr. Markovich can build is if the buffers are waived or the plan is redesigned.

Dean - this property can cause flooding and mud flows into the 2 surrounding neighborhoods. He was asking for an agricultural use during assessments. Mr. Markovich has not been a good neighbor. He thinks Mr. Markovich needs to follow the rules the same as every other developer.

Dean - moved to concur with the Zoning denial, second by Gould. Unanimous with 1 absent (Bellisario).

Dean - moved to adopt a resolution, second by Thompson. Unanimous with 1 absent (Bellisario); becomes Resolution C.S. No. C-4259.

Rob Barnett - Helenbirg Properties, LLC owns a piece of the property which contains the existing pond, but the boundaries of the pond exceed the area of the land owned by Helenbirg. So far, they have been unable to identify all of the owners of the pond. The Parish cannot accept the donation until they are in contact with all of the owners of the pond.

Gould - the moratorium is in place to prevent the developer from selling anymore lots until the pond issue can be solved.

Groby - moved to adopt, second by Stefancik. Unanimous with 2 absent (Falconer, Gould); becomes Resolution C.S. No. C-4261.
