# SPECIAL ITEMS PUBLIC HEARING OF THE 2012 PARISH OPERATING/CAPITAL BUDGETS

Gould - 1) Ord. Cal. No. 4647 - Ordinance adopting the 2012 Parish Operating Budget. (Introduced 9/28/11) (Tabled 11/3/2011)

Carlo Hernandez -he appreciated the budget being available on-line and the public hearings were very educational. He is hoping the organizational charts will eventually be on-line. He still has concerns about the lighting districts. Some of the districts have almost a million dollars while others have nothing. He especially hopes a lighting district will be created or extended to include Highway 1088 from Interstate 12 north to the new high school. He is requesting the Council to review all of the lighting districts.

Falconer - he has the recommendations of the Council Budget Review Committee to be read and entered into the record. (Exhibit A)

Stefancik -moved to adopt, second by Burkhalter. Unanimous with no one absent; becomes Ordinance C.S. No. 11-2637.

Gould - 2) Ord. Cal. No. 4648 - Ordinance adopting the 2012-2016 Parish Capital Improvement Budget and Program, and further identify Fixed Assets & Grants Awards. (Introduced 9/28/11) (Tabled 11/3/2011)

Burkhalter - moved to adopt, second by Stefancik. Unanimous with no one absent; becomes Ordinance C.S. No. 11-2638.

#### **PRESENTATIONS**

Hamauei - moved to move up Presentation No. 2 to introduce the Junior Council Members, second by Canulette. Unanimous with no one absent.

Gould - 2. Introduction of the Junior Council Members for December: Miles, Ella, Michael, Addie, John and Mary Margaret Hamauei (grandchildren of Council Member Al Hamauei). (Hamauei)

Hamauei - introduced his grandchildren: Miles, Ella and Addie Hamauei and presented them with certificates. His remaining grandchildren had to return home out-of-state.

Gould - 1. Presentation of awards to outgoing Council Members: Gary Cooper, Becky Howell, Al Hamauei, Henry Billiot and Ken Burkhalter along with outgoing Parish President Kevin Davis for their dedicated service to St. Tammany Parish. (Gould)

Mike Sevante - this is the third time the Council has seen change under the Parish Home Rule Charter. It is a somber event having to say goodbye to colleagues who have worked closely with over the last several years. However, it is a necessary part of government which is good in the long run as it encourages growth within local government.

Sevante - presented awards to Henry Billiot for 12 years of service, Ken Burkhalter for eight years of service, Al Hamauei for five years and Rebecca (Becky) Howell and Gary Cooper for four years of service.

Gould - he has been given the honor of leading a group of individuals in honoring President Kevin Davis.

Steve Stefancik, Jerry Binder, Marty Gould and Bill Oiler each talked about Kevin Davis' 12 years of service to the Parish of St. Tammany.

Gould - presented a flower bouquet to Maria Davis on behalf of the Council and Parish Government for sharing Kevin for the last 12 years and presented a clock honoring Kevin Davis for "Building Excellence" in this Parish. Congratulated Kevin Davis for being named the Louisiana Director of Homeland Security by the Governor.

Kevin Davis - thanks the Council and the people of St. Tammany for allowing him the honor to serve for the last 12 years. He leaves the Parish in the good hands of Pat Brister a little earlier than expected due to the call from the Governor. He is proud of the people of the Parish because without their involvement, the Parish would not be where it is today.

Gould - 4. Certificates of Recognition to the Fontainebleau High School Girls' Volleyball Team for winning the Division I State Championship. (Binder/Gould)

Gould - thanks to the ladies of the volleyball team for sitting through the presentations.

Stefancik - thinks this needs to be discussed more.

Leslie Long - the Council has until February 28 to appoint an auditor.

Stefancik - moved to postpone to January 12, 2012 meeting, second by Bellisario. Unanimous with no one absent.

Gould - 15. Resolution C.S. No. C-3287 - Resolution to consider and take action with respect to adopting a resolution approving the holding of an election in St. Tammany Parish Fire Protection District No. 1 to authorize the renewal of a special tax therein. (Gould/Davis)

Larry Hess - Fire Chief for Fire Protection District 1 - this is a renewal of a 10-year tax. Historically the Fire District rolls back its millages. It is judicious to ask for approval of 35 mils, but the Board has no intention to roll forward from the 30 mils it currently collects. They are just asking for the flexibility of being able to roll forward.

Burkhalter - moved to adopt, second by Hamauei. Unanimous with no one absent.

Gould - 16. Resolution C.S. No. C-3288 - Resolution to consider and take action with respect to adopting a resolution approving the holding of an election in St. Tammany Parish Recreation District No. 11 to authorize the renewal of a special tax therein. (Gould/Davis)

Mike Lopez - this is a request to extend the current millage of 10 mils for 8 more years. The number of children in the Abita Recreation District has increased by 60%. This is the largest park without a gym and the mils will go toward the building of a gym. They already have 10 acres to build on.

Hamauei - moved to adopt, second by Thompson. Unanimous with 1 absent (Cooper).

Gould - 1. St. Tammany Parish Recreation District #1appealing the exemption decision of the Parish Road and Drainage Impact Fees Administrator. (Tabled 11/3/11)

NOTE: To concur with the Administrator decision, a simple majority vote is required and adoption of a resolution.

NOTE: To override Administrator decision, a majority vote of the entire Council is required and adoption of a resolution.

Stefancik - moved to table, second by Canulette. Unanimous with no one absent.

Gould - 2. Charles Walker appealing the Zoning Commission APPROVAL on November 1, 2011 to rezone 1.5 acres located on the northeast corner of Commercial Drive and Brown's Village Road from I-1 (Industrial District) to I-3 (Heavy Industrial District). (Ward 8, District 14) (ZC11-10-082) (Applicant: Parish Council by Motion 9/6/11)

NOTE: To concur with Zoning APPROVAL, a simple majority vote is required and introduction of an ordinance.

NOTE: To override Zoning APPROVAL, a majority vote of the entire Council is required and adoption of a resolution.

Paul Mayronne - on behalf of Mr. Walker. Mr. Walker's position is simple. He owns property adjacent to this property asking to be rezoned to I-3. His client does not believe I-3 intensity is appropriate to this area. There are businesses such as churches and a phlebotomy school near there, and it is not an appropriate area for steel mills, storage of petroleum or a refinery. His client is requesting the Council override the Zoning Commission approval.

Lisa Gentz - corporate counsel for Gas and Supply Industrial Welding Supplies. The company services clients in the area of the property. There are 3 streets in the area. In 2008, the company requested to be rezoned from M-1 to M-3. When the new zoning map was adopted the property was zoned I-1. The area contains several construction companies, including Bella Marble and Magnum Construction and a concrete plant. Mr. Walker has a batting school on the property next to this, and it appears, he is building a batting cage, creating an outdoor recreational facility. This area is industrial and there are already propane storage tanks in the area. There is a fire department substation that has a 15,000 gallon tank in its parking lot. Her client was approved for the rezoning in 2008 and again now. They are asking the Council to concur with the Zoning Commission approval.

Mayronne - this is an industrial area, but it is I-1 and there is a significant difference between it and I-3. During comprehensive rezoning, staff felt the area was more appropriate for I-1.

Gentz- her client needs I-3 for the bulk storage of propane gas. They are an industrial welding and gas supply company which sells argon, medical oxygen, propane, etc.

Council Discussion ensued.

Binder - moved to table, second by Hamauei. Motion passed 11 yeas, 2 nays (Billiot, Burkhalter) and 1 absent (Falconer).

Gould - 3. Jeff Schoen, for Ernie Nagim Construction Company, et al, appealing the Zoning Commission DENIAL on November 1, 2011 to rezone 6.5982 acres south of Lonesome Road, east of Highway 190 from A-4 (Single Family Residential District) to NC-1 (Professional Office District). (Ward 4, District 10) (ZC11-11-092)

NOTE: To concur with Zoning DENIAL, a simple majority vote is required and adoption of a resolution.

NOTE: To override Zoning DENIAL, a majority vote of the entire Council is required and introduction of an ordinance.

Jeff Schoen - representing Nagim Construction. This is a 6.6 acre parcel on Lonesome Road. Historically everything in this area was developed in a residential manner. The client would like to change the A-4 zoning to neighborhood commercial zoning as Staff recommended. NC-1 would provide for small scale services with minimal impact for the residents of the neighborhood. The property currently has 12 parcels of record with 3 owners who could develop it into 12 single family sites with 12 driveways, which would not benefit anyone in the Lonesome Road corridor. His client's plan calls for only 2 curb cuts and a 30 foot no-cut buffer in order to maintain a green buffer for this beautiful area. The structures would look like residences and have less negative impact.

William Phillips - lives in the Lakes and is here representing the homeowners for all eight residential subdivisions in this area. They are united in opposition of further degradation of this area. The Zoning Commission denied this request. He finds the statement of less impact than residences to be absurd. There is an existing office park next to this which has 8 buildings and 128 parking spaces which are full everyday. This new complex could add 1000 vehicles a day. There is enough vacant office space on the market, more does not need to built.

Schoen - Mr. Phillips makes some interesting points. His client thinks 12 curb cuts and 90 foot lots is not the answer either. He asks the Council to make the best decision.

Phillips - they would rather have 12 driveways than to have 2 driveways leading to offices which belong on Veterans Highway. They are the citizens and they do not want any other services this would provide. Residential means residential.

Council discussion ensued.

Billiot - moved to concur with the Zoning denial, second by Hamauei. Motion passed with 12 yeas, 2 nays (Dean and Cooper), and no one absent.

Billiot - moved to adopt a resolution, second by Burkhalter. Unanimous with no one absent; becomes Resolution C.S. No. C-3290.

Gould - 4. Kelly Hilderbrand appealing the Planning Commission APPROVAL on November 9, 2011 of a Revocation of a portion of Red Rooster Road located in Dawes Subdivision. (Petitioner: Chris Jean) (Ward 8, District 9) (REV11-10-004)

NOTE: To concur with Planning APPROVAL, a simple majority vote is required and

adoption of a resolution.

NOTE: To override Planning APPROVAL, a majority vote of the entire Council is required

and introduction of an ordinance.

Theresa Smith - her family has lived on Red Rooster Road for over 80 years. She has been there for 49 years. There has never been an accident. This neighbor bought two pieces of land on either side of the road, and now, she wants to combine her land and put a house in the middle. They are planning to close the entrance to the subdivision and run a new road through another subdivision onto a highway. They are going to put in drainage that is not needed because they have never flooded. There are 66 people on this road, and they do not want this. The children will now have to walk farther to catch the school bus that will now be on a blind curve.

Chief Ellim Warhorse - this Parish has been eliminating her people for years. It is not fair for this woman to block all of the people who live here.

Carolyn Jones - right now they have good access and visibility off of their road onto the highway. Now they will have to enter the highway into a dangerous curve.

Jeff Schoen - This case is simple. They are asking that a 12-foot wide road surface be revoked and replaced by a 20-foot surface with drainage that meets Parish specifications. The road has been 12 feet wide for over 50 years. There are no fences or a place to wait for the bus. Two cars cannot pass on the road at the same time. His client feels this will be an improvement for the area. They plan to build a new road and tie it into an existing public road with superior access that would allow the children to be picked up by the bus someplace other than Robert Road.

Smith - they have had ambulances, buses, fire trucks and 18-wheelers come down their road. There are fences farther down. The children have room to walk on the side of the road. This new road is not going to benefit the residents at the end of the road.

Jones - the new road will exit into the subdivision road which has a lot more traffic and turns onto Robert Road into a very dangerous curve.

Schoen - he understands and respects the residents of this area. They have been there for a long time. He thinks their comfort at being there and their heritage have blinded them to the potential safety hazards. In the 21<sup>st</sup> Century, can the Parish justify maintaining a 12 foot road?

Bernadine Atwood - the new road is just the back of her property and will not benefit them. The road is a landmark named for fighting roosters.

Council discussion ensued.

Schoen - his client has agreed to provide a right-of-way extending the full width of the property, and he feels they are doing their part by removing the unsafe road from commerce. They will also build a covered bus stop for the children on the new road rather than Robert Road.

Bellisario - this is a complex case to consider based just on the map. This road was taken into the maintenance system in 1993. It is a substandard road that is not easily accessible to the mowers. He will commit to looking into using Capital Money to widen the other end of Red Rooster Road.

Bellisario - moved to concur with the Zoning approval, second by Canulette. Motion passed with 13 yeas and 1 nay (Howell).

Bellisario - moved to adopt a resolution, second by Canulette. Unanimous with no one absent; becomes Resolution C.S. No. C-3291.

Bellisario - moved to consider introduction of Ord. Cal. No. 4698 earlier tabled, second by Canulette. Unanimous with no one absent.
