Emergency Ordinance to create prospective precincts, change the configuration, boundaries, or designations of its election precincts in accordance with Louisiana Revised Statutes 18:532 and 18:532.1; and to provide a polling booth location pursuant to Louisiana Revised Statute 18:533; and to amend St. Tammany Parish Code of Ordinances Section 2-41 to apportion certain precincts to the correct council district.
- -Emily Couvillion explained that the purpose of this ordinance is to correct legal descriptions and maps from the 2019 ordinance. She also explained that there needs to be a motion to amend because of changes in the title.
- -T. Smith asked questions about what exactly is being corrected and why is it being done with such short notice.

- -Davis asked about a couple of precincts in his district and why they weren't on this ordinance.
- -Toledano moved to amend, seconded by Fitzgerald. Motion passes with 12 yeas, 1 abstention (T. Smith), and 1 absent (Dean).
- -Toledano moved to introduce and adopt, seconded by Stefancik. Motion passes with 12 yeas, 1 abstention (T. Smith), and 1 absent (Dean); becomes Ord. Cal. No. 6739 and Ord. C.S. No. 21-4590.
