-Ms. Krieger explained the Levee Board and its function. Glen Ledet gave a PowerPoint presentation regarding the current levee systems in the Parish and improvements that can be made as well as restoration and resiliency. He gave an update of the Coastal Study status.

-T. Smith – asked a question about effects on future developments.

-Davis - asked about an approximate timetable.

-Ledet –6 - 12 months.

-Airey – asked about the price.

-Ledet – depends on the design elevation. It could be a billion to a few billion dollars but it could be done in stages.

-Binder – made comments regarding flooding events and levees and about credits/reduced insurance, etc.

-Krieger - went to Washington and met with the Congressional Delegation.

-Toledano – complimented the members who were at the meeting.

** Long gave a briefing on the American Rescue Plan Act. The guidelines came out and they are 151 pages. The FAQs are 18 pages long. Finance is currently reviewing the guidelines. The Parish will receive \$50 million. They will get ½ now and ½ later. Expenses must be incumbered by 2024 and expended by the year 2026. The Parish must report quarterly.

-President Cooper – there will be a meeting with Chris Masengil and St. Tammany Corp. to review the guidelines.

-There being no further business, meeting adjourned at the call of the Committee Chairman.
