## St. Tammany Parish Government:

Action Plan Amendment No. 3 to the Action Plan for Community Development Block Grant Disaster Recovery (CDBG-DR) Program Pursuant to Federal Register Notice 78 FR 69104

On May 29, 2013, the U.S. Department of Housing and Urban Development (HUD) announced an allocation of \$10,915,000 of Community Development Block Grant Disaster Recovery (CDBG-DR) funds to support St. Tammany Parish's recovery from Hurricane Isaac.

Prior to releasing the funds, HUD requires that grantees create an Action Plan that documents the proposed use of funds, and publish it for public input. HUD approved St. Tammany Parish's initial Action Plan on February 12, 2014.

The most recent amendment, Action Plan Amendment No. 3, is now available for public review. **Summary of Action Plan 3:** The Parish is proposing to move \$2,533,605.33 from the Northshore Center for Innovation and Learning (Northshore Technical and Community College campus rebuild-Phase 1)("NTCC") and create a new activity to fund the construction of a NTCC Classroom Construction within the St. Tammany Parish Multi-Use Facility ("MUF").
